Captain Kevin Doran

Fly Fishing for Bass – Top to Bottom with Captain Kevin Doran\

"KD" has been fishing for Largemouth
Bass since his childhood. KD's passion
for catching LmBass using topwater tactics
is legendary. He began as a young boy
over fifty years ago on the shores of
Clear Lake in Northern California.



He cast his first fly rod and a "Loyd's Luck Lures" balsa popper for big Clear Lake Bass. His passion for taking bass on top carried forth into his Delta fishing and guiding career, which established him as one of the premier Delta "Bass masters" utilizing fly fishing tackle and developing unique fly patterns and presentation techniques. He has been featured in numerous articles in industry publications, including California Fly Fisher and Fly Fisherman (California's Largemouth Paradise, May 2007).

Kevin authored the definitive Delta Largemouth article, "Tactics for Delta Bass" (California Fly Fisher, April 2001) which was ground breaking in bringing forth awareness to fly anglers about the Delta Largemouth fishery. Kevin has been featured in books such as "Fly Fishing the California Delta" (Costello/Sherman), "Fly Fishing California's Great Waters" (Blanton), and starred a supporting role in "Bass: The Movie" (Howard Films).

Along with his Bass-n-Fly team members, Kevin has been involved with lodge guide training, rod and tackle development, and educational seminars and presentations.

Lesson Learned

As Fishmeister for the club's Fuller Lake trip in August, I was sorry to see that only two others had signed up. However, as events unfolded, it was good that we had a small group.

Henson, Dennis and I fished long hours on Fuller, with only **very** occasional fish activity seen. The best possibility of any action that our group had was one **very** slight tap, tap on my nymph, that might well have been a subaquatic weed bumping the line. Other fishermen were also scarce, including shore anglers fishing bait. In one area where there are often five or more set up, there was only one, and he left in a couple of hours.

According to DFW website, the lake was last stocked on April 26 this year, but since we are somewhat experienced fly fishers, with some years of learning this lake and the flies to use and the areas to fish, I thought there was a reasonable possibility of some success. Not to happen!

In retrospect, on a popular, easily accessed "put-and-take" body of water, if there is only one "put", with anglers "taking" over an almost four month period before we made our trip, my expectations were somewhat unrealistic. In addition, the August water temperature would likely drive the trout to lie on the bottom, seeking cooler, more highly oxygenated water.

The lesson I take away from this experience is to consider carefully all aspects (or as many as you can think of) when planning a trip. Trips with fellow anglers from TVFF are always fun, but not always productive.

Re: URGENT Request for Reclamation and DWR to Issue a New California Water Fix Draft EIR/EIS to Finally Disclose and Analyze Adverse Environmental Impacts and to Develop and Consider a Reasonable Range of Alternatives Increasing Delta Flows

On August 18th, a coalition of conservation, fishing, and public interest organizations sent a letter to state and federal agencies requesting a new (and complete) environmental analysis of Governor Brown's Delta Tunnels (CA WaterFix) proposal.

LETTER SUMMARY

Our public interest organizations write to you in this latest of many efforts to finally obtain compliance with the National Environmental Policy Act (NEPA) and the California Environmental Quality Act (CEQA) during the environmental review the California Water Fix Delta Water Tunnels proposed project.

The Water Fix Delta Water Tunnels would divert enormous quantities of freshwater that presently flow through the Sacramento River, sloughs, and the San Francisco Bay-Delta estuary before being diverted for export from the South Delta. Due to the new points of diversion north of the Delta, freshwater that presently contributes to water quality, water quantity, fish, fish habitat, Delta agriculture and public health by flowing through the already impaired Delta would instead flow through massive Tunnels no longer providing benefits within the lower river, sloughs, and the Delta. This undeniable truth is obvious. And this undeniable truth has been ignored for years by the federal and California agencies trying to take the water away from the Delta.

Extinction is forever. The San Francisco Bay-Delta estuary is the most important estuary in the Western Hemisphere. Given the destruction threatened by the Water Tunnels, it is disturbing to learn that the federal Bureau of Reclamation (Reclamation) and California Department of Water Resources (DWR) "target completion of a Final EIR/EIS by September 2016. . ." for the Water Fix project. (DWR and Reclamation letter to the California Water Resources Control Board, p. 2, August 3, 2016). We are supposed to have a government of laws not of rulers. Yet Reclamation and DWR apparently plan on ignoring our laws such as NEPA and CEQA by issuing a patently insufficient Final EIR/EIS [Environmental Impact Report/Environmental Impact Statement] for this controversial project. They must instead proceed in the manner required by law by issuing a new Draft EIR/EIS for public review and comment.

To briefly summarize, the U.S. Environmental Protection Agency (EPA) gave the most recent Draft NEPA and CEQA environmental review documents for the project its failing grade in October 2015. The EPA expected that the essential but missing environmental information and analyses would be supplied by other agencies, in particular, the California State Water Resources Control Board (State Water Board) during their review processes. That did not happen.

In addition, the July 2015 Drafts contained false denials by Reclamation of the project having significant adverse impacts on Delta water quality, water quantity, fish and fish habitat. But earlier this month, the Biological Assessment (BA) issued by the same agency, Reclamation, under the Endangered Species Act (ESA) made contrary determinations of "likely to adversely affect" several endangered and threatened fish species and their designated critical habitats.

The new Final Guidance issued earlier this month by the Executive Office of the President, Council on Environmental Quality (CEQ) on consideration of the effects of climate change in NEPA reviews graphically demonstrates the inadequacy of the NEPA process for this project. The Drafts have at all times also failed to include the heart of such documents under both NEPA and CEQA -- the required range of reasonable alternatives. In this case, an obvious alternative that Reclamation and DWR have consistently refused to include and consider is to increase rather than decrease freshwater flows through the Delta by reducing exports. A Ninth Circuit Court of Appeals decision issued last month makes it crystal clear that this persistent refusal by Reclamation to consider alternatives reducing exports violates NEPA. As a result, the public review and comment time periods afforded for the Draft NEPA and CEQA documents were worthless in terms of allowing informed and meaningful public review and comment. Issuance of a Final EIR/EIS for the Water Fix project without having first prepared and circulated for public review and comment a new Draft EIR/EIS correcting these deficiencies will constitute failure to proceed in the matter required by law, including NEPA and CEQA. There are many, many deficiencies in Reclamation's and DWR's NEPA and CEQA processes to date during the Bay Delta Conservation Plan (BDCP)/Water Fix review process. In confining this letter to only several of the elementary NEPA and CEQA violations, we do not in any way withdraw or modify any of the comments we have made previously during these processes.

Big Bass & the BSA Fly Fishing Merit Badge

We just completed the 2016 Fly Fishing Merit Badge Program at the Wente Scout Reservation summer camp. This is the third year we have done the program and each year we've seen more interest and growth in the number of young men and leaders participating. Over the 8 week summer camp we had 96 scouts do the merit badge and 29 adult leaders learning about fly fishing. This was a significant increase over the 2015 program that had about 57 scouts.

One of the requirements of the merit badge is to catch a fish with a fly rod. This year 95 of the 96 scouts completed that requirement by catching either a Blue Gill or a Bass. For some of them it was the first fish they ever caught! The pond at the camp has been designated catch and release so the fish were all put back.

There were 19 experienced fly fishermen from 7 different Fly Fishing clubs who volunteered their time to teach the class at Wente and from what I've heard from the volunteers everyone enjoyed their time at camp. We even had one volunteer spend 6 weeks at the camp! The camp Director also tells me there has been nothing but positive reviews from the scouts and adults that have taken the class.
